1) UPDATES/REPORTS

- 1) Reports on pairing with board members: Only Claude has heard from his assigned partner.
- 2) Update from Spanish Focusing Institute and the others who signed the letter. Nothing reported
- 3) History document update Nothing to report. The document is ready for final editing.
- 4) Concerns document -- letting the world know
 The document has been finalized and is ready to be posted on the TIFI website. Question
 submitted to CT re when this might be done and where it is to be posted. Meanwhile,
 Claude will inform his community about the document. Ruth has submitted an article to be
 published in the Feb. TIFI newsletter in the ILC column on these new policies.
- 5) Executive Director updates ED traveling, so no updates this time.
- 2) Pilot Program follow up
- Go over list of CiT's and assign liaisons- this was done.
- Go over the list of questions for the interviews To do at next meeting (See draft list at end of these notes.)
- It was decided that each liaison will send individual letters to the CiT and mentor who they've volunteered to be liaison for..
- It was decided that Ruth will draft a letter to be sent to the other CITs and their certifying coordinators to inform about pilot program.
- List is not complete; there are two more CITs from Belgium; Plus, Yong Wei (trains with Karen Whalen), Evelyn (trains with Rob Foxcroft) are also a CITs. Others? Who at TIFI has access to complete list of CiTs?
- Claude already sent letters to the two additional CITs in Belgium. He will follow up.
- 3) Coordinators -- Beginning a series of conversations about Coordinators

There are 2 tasks:

- a) As an organ of the Institute, the ILC (along with the Board) should have some sense of what its answers are to the guestions in Strategy 2A of the Strategic Plan
- b) Also as an organ of the Institute, the ILC should actively engage all Coordinators in the questions in Strategy 2A, to get their input, and their reactions to the tentative answers of the ILC and Board
- 4) Pilot program is intended to provide some more standardization. There is still a lot of freedom of the "certifying Coordinator".

Next time: Going back to the question: What does a coordinator do? Claude will not be there at the next meeting.

5) We welcome Yong Wei officially as an ILC member.
