# III. APPROVAL OF THE MINUTES

#### VII. EXECUTIVE DIRECTOR REPORT

Catherine presented her written mid-year ED report.

Catherine and Darryl presented the financial report through June, 2022. Highlights of the report include:

- Year-to-date revenues are below expectation. Donations, especially donations from large donors, tend to come in the latter half of the year. Discussion ensued on planned events that should also help us meet our annual revenue projections.
- · Year-to-date expenses overall are tracking as expected

# VIII. STRATEGIC CONVERSATION

Coordinator and former Board member Rob Parker joined the meeting to discuss how we might better "brand" Focusing. Catherine opened the conversation expressing that there is a new concern that as automated translation apps come to be used more and more, they are never likely to pick up on our meaning of the word "Focusing." A key takeaway from the discussion came in the form of something Gene Gendlin said frequently, which is that words like "Focusing" have common understandings that do not reflect our intention; therefore, in order to differentiate our intention, an additional word/modifier is likely needed (e.g. "... Focusing"). Rob suggested "Experiential Focusing" as a phrase that Gendlin himself used, especially in his early writings. One board member commented that the phrase "Experiential Focusing" therefore is loyal to Gendlin.
