- I. Approval of Minutes Minutes from 2023.10.13 unanimously approved.
- II. Report on 2023 Third Quarter Financials Darryl and Catherine pointed out a few specifics on the numbers as presented in the written report. This report showed costs in expected patterns. Money is being spent consistent with TIFI's vision. Generally, most donations tend to come in during the fourth quarter. It was acknowledged that contract courses have generated a significant income. The website expenses exceeded the allocated budget, this has been tracked very carefully. Overall, revenues and expenses are on target.
- III. Review of IRS form 990 As a USA non-profit corporation, TIFI is required to make a tax return (the 990) in compliance with its non-profit status. The financial numbers match our audit. This document will be filed by November 15. The Board expressed appreciation for Darryl's expertise in this matter.

- IV. Annual Meeting with Members Two meetings have been scheduled on Sunday 12<sup>th</sup> November for this event, at 13:00 pm and 19:00 pm (NY time).
- V. ILC & Board Interaction Flor will attend the ILC meeting on November 14<sup>th</sup> and Veronica on December 12<sup>th</sup>. The Board aims to work together with the ILC whilst understanding each other's roles in TIFI. The Board of Directors meeting agendas are sent to the ILC. They have received an invitation to send a representative to the Board of Director meetings.

#### VI. Executive Director (ED) Report

Catherine submitted a written report in which she discussed these topics:

- <u>Responses to the Conflict in the Middle East –</u> On the Board's behalf, Catherine wrote to Israeli Coordinators to let them know that we will delay by another year the scheduled increase in membership and certification fees. Catherine, along with Flor Sassoli, Veronica Urioste and Laura Bavalics conducted five "Compassionate Conversations" to allow people to gather to express their anxieties and hopes around the situation.
- <u>FOT Conference & Pricing</u> The FOT conference was successful with 338 registrants from 38 countries, though it brought in less than budgeted, because more people than expected chose the lowest price option.
- <u>Videos.Focusing.org</u> this is the site for buying videos this will be launched once some upgrades are completed.
- <u>Spanish Language Meetings</u> Catherine has been meeting with Spanish speaking Coordinators and translators to discuss the best choices for translating the terms of Focusing/TAE/POI to Spanish.
- <u>Webmaster Joel Brodsky has left</u> He has decided to retire. Catherine has allocated his work to other staff, and expressed appreciation for his several years of valuable service.

#### VII. Potential Actions in 2024

- Veronica Urioste informed the Board that she will be stepping down from the Board of Directors in May 2024. This is due to her retirement and the decision to travel.
- Evelyn Fendler-Lee is stepping down from the Board of Directors in summer 2024, having served on the ILC and then the Board for a total of 6 years.
