# ANNUAL FINANCIAL AUDITOR'S REPORT

Valerie Jashi, the accountant who does TIFI's annual audit, joined the meeting for about 20 minutes to report to the Board on the annual financial audit. She reported that overall the finances are healthy. Expenses as well as revenues are up, and in 2023 there was a small surplus. Valerie commented that this is a strong financial position for a non-profit. She also commented that maintenance of the books is "impeccable." After the Covid-year decline, there has been a clear improvement in revenues.

The Board asked Valerie about how to account for expenses outside of regular operating, such as the \$20,000 that the board approved for professional services for intellectual property. Valerie confirmed that this expenditure was appropriate and could be accounted for as a capital expenditure rather than an operating expense.

### DRAFT REVISION OF TIFI ORGANIZATIONAL GOALS

Each goal was read out and discussed, in a few cases some edits were suggested, which Evelyn and Catherine noted for possible further revisions. Suggestions included such things whether to explicitly add in mentions of TAE and FOT, and how to describe our desire for diversity in membership and programs. Overall, the Board feels that the revisions are clear and inspiring. The draft TIFI Goals will be reviewed again at the next Board meeting.
